PUPPY CONTRACT:

Buyer has 72 hours EXCLUDING WEEK-ENDS to have Dog or Puppy checked by a veterinarian. If any defects are found that will hinder Dog or Puppy from being a pet, then:

1. Buyer must bring a written statement from veterinarian on his findings to Seller.
2. Buyer must return Dog or Puppy to Seller for the next available replacement puppy.
3. Dog or Puppy must be returned on the day of the veterinarian check. If Buyer does not wish to return Dog or Puppy for a replacement, then Seller is not responsible for Buyer's decisions on the care of the Dog or Puppy after 72 hours. This contract includes the entire agreement of the parties. There are no collateral agreements, nor is contract dependent up any conditions not stated herein.
4. Buyer must not treat Dog or Puppy. Seller will NOT pay for Buyer's veterinarian bill.

WE DO NOT GUARANTEE AGAINST PARVO, CORONA, OR ANY TYPE OF INTESTINAL VIRUSES, NOR AGAINST WORMS OR COCCIDIOSIS, or conditions that could be caused by environment, ie kennel cough. * EXCEPT WITHIN INCUBATION PERIOD

PET GUARANTEE: WE DO GUARANTEE AGAINST GENETIC DEFECTS THAT ARE LIFE THREATENING OR WILL HINDER THE ANIMAL FROM BEING A GOOD HEALTHY PET DIAGNOSED BY A VETERINARIAN BEFORE THE PUPPY'S FIRST BIRTHDAY:

If the buyer's Veterinarian finds a genetic birth defect within the first year of the puppy's life that will hinder the DOG or PUPPY from being a pet (life threatening) contact the SELLER with all information from the veterinarian on his/her findings for a possible replacement puppy. Seller will NOT PAY for any veterinarian bills.

If Buyer does not wish to return Dog or Puppy for a replacement, then Seller is not responsible for Buyer's decisions on the care of the Dog or Puppy. This contract includes the entire agreement of the parties. There are no collateral agreements, nor is contract dependent up any conditions not stated herein.

PET GUARANTEE:

"PET" means this Dog or Puppy is sold as a pet only and is not considered as breeding or showing quality per breed standards. The Seller guarantees that the Dog or Puppy is healthy and suggests examination by a veterinarian, at Buyer's expense for the satisfaction of the Buyer. If veterinarian finds any defects, the puppy will be replaced with another puppy upon return of the puppy within 72 hours after purchase.
